This letter is provided in response to your Notice of Disapproval (NOD), dated April 1, 2010 pertaining to the Department of the Army's RCRA Class 3 Permit Modification Application, OB/OD Corrective Action Management Unit, dated January 2010. We have reviewed the two comments provided by your office regarding Part A of the permit modification application and agree with the requested changes. As such, we are providing a revised Part A with this submittal in response to your comments.

The Part A permit modification application, attached, has been updated to address the appropriate process code (Comment #1) and uses the updated Part A application form dated November 2009 (Comment #2). Because of the changes requested as part of Comment #1, additional edits to the supporting text for the Part A attachment were prepared.
