Your failure to communicate timely status updates caused OSE personnel from District 1, located in Albuquerque, and the Hydrology Bureau, located in Santa Fe, to travelling 3 hours one way to Ft. Wingate without being able to witness the cementing of G-191 POD1. This unprofessional lack of communication wasted significant time and state resources. As scheduling constraints will prevent me from travelling to Ft. Wingate a second time for this well, I am issuing revised conditions of approval detailing information which must be collected and provided to the OSE on an ongoing basis as the plugging operations proceed. Please note that providing the OSE with an opportunity to witness the plugging operations, including by providing work schedules, is an original condition of this approved plugging plan. Failure to comply with this may result in a formal reprimand to the licensed driller. Please carefully review the attached conditions of approval and let me know when you have read them.

Hi everyone,

Here's my summary of our meeting this morning. I will be sending out revised conditions for POD-1 (well 68) only. As of now the previously issued conditions will hold for POD-2 (well 69).

- G-191 POD1 (well 68) currently has a static water level of 168' bgl
 - May be losing water behind pipe to another formation
- Rough Stratigraphy in vicinity of obstruction per Ben Moayyad:
 - 1040' to 740' bgl is a shale
 - 740' to 720' is sandstone
 - 720' to 640' is shale
 - **Please provide the source for this information**
- Based on above stratigraphy the following procedure will be followed
 - Perf from 740' to 720'
 - Set cement retainer at 720'
 - Pump cement to exceed hydrostatic pressure
 - From static water level of 168':
 - ~414 psi (assuming no inter-aquifer exchange)
 - Estimated pressure assuming flowing w/ shut-in pressure of ~60 psi:
 - 647 psi
 - If water is being lost to another formation this may be a better estimate of the hydrostatic pressure.
 - Proceed with perforations and plugging as previously described

I will be working with Chris on finalizing revised conditions for the plugging. Currently aiming at

Nathan,

Our driller has made numerous attempts to remove the obstruction in Well 68, ongoing since last night, 8/18/23. They attempted removal using a corkscrew "pig tail" tool. They also attempted to use downhole video between attempts to re-evaluate the tools and procedures. Earlier today following failed attempts at pulling the obstruction, they applied force using drill pipe to try to push it to the bottom of the well. This was also unsuccessful. The efforts to push and pull on the obstruction have exceeded reasonable expectations. We believe further efforts would only cause greater risk of well collapse and risk closing the existing channel to allow flow of grout to the screen.

Please let us know as soon as possible if there are any to proceeding with plugging, as per the previously approved procedure. I can be reached at 973-803-2128.
