
The New Mexico Environment Department (NMED) received Fort Wingate Depot Activity's (The Permittee) letter, dated October 6, 2006 requesting an extension for submittal of the Kickout Area Delineation Work Plan for the Open Burn/Open Detonation (OB/OD) Unit to June 29, 2007. The Permittee and NMED consulted with the Navajo Nation and Pueblo of Zuni on November 15, 2006 regarding the Work Plan submittal date.

NMED erroneously referenced the extension request for the submittal of the RCRA Facility Investigation (RFI) Work Plan for Parcel 21 in the approval letter dated November 16, 2006. NMED hereby approves the extension request for the submittal of the Kickout Area Delineation Work Plan for the OB/DO Unit. The Permittee must submit the Work Plan no later than June 29, 2007. All parties are in agreement regarding this submittal date. The Permittee must take the necessary steps to ensure that further delays do not occur.
