Dear Mr. Maestas:

The purpose of this letter is to request an extension from March 15, 2024, to April 30, 2024, for the submission of the Final RCRA Facility Investigation, Phase 2 Work Plan, Parcel 22, Fort Wingate Depot Activity. The proposed Phase 2 Work Plan will address the comments in the New Mexico Environment Department (NMED) Disapproval of the RFI Report Parcel 22 Revision 2.0 (May 10, 2018), as well as Comment 5 in the NMED Approval with Modification Final Northern Area Groundwater RCRA Facility Investigation Report, Revision 3, dated October 19, 2023, to: Submit a Work Plan to Remediate Soils Where Perchlorate Concentrations Exceed Applicable SL-SSL.

As you are aware, the Army awarded a contract to complete multiple outstanding documents in the FWDA Northern Area and is actively preparing documents for submission to NMED by March 15, 2024. However, the Phase 2 Work Plan for Parcel 22 is particularly extensive and will require additional time to provide a quality document for NMED review.

The Army is seeking an extension in time under RCRA Permit Section I.M. in order to complete the associated work plan by April 30, 2024.
