The Department of the Army respectfully submits this letter to serve as notification to the New Mexico Environment Department – Hazardous Waste Bureau (NMED-HWB) that on or about May 10, 2019, both the Navajo Nation and the Pueblo of the Zuni received the Final Bench and Pilot Test Work Plan, Fort Wingate Depot Activity, McKinley County, New Mexico for review and comments. The 60-day Tribal review period for that document expired on July 9, 2019 and the Army has not received comments from either Tribe about this report.

Pursuant to our agreement, NMED agreed to provide a response to the Army regarding the report only after the Army demonstrates the Army has reviewed and responded to Tribal comments. With the expiration of the review period without comments, the Army assumes the Tribes have no comments.
