This letter is in response to New Mexico Environment Departments (NMED's) February 1, 2019 letter regarding submittal dates for multiple documents at Fort Wingate Depot Activity, New Mexico. Specifically, this letter is in response to Item # 2 on the Summary Table related to FWDA-15-001, Groundwater Supplemental RFI Work Plan. The Army is requesting to set a submittal date for the Groundwater Supplemental RFI Report of December 31, 2021. This request for an extension is based upon the fact that the Army had to procure a new contract to conduct this work due to the expiration of the Period of Performance (POP) of the then contract as a result of lengthy document review time. Further, the BRAC funding for this work was not received until March, 2019. The new contract is now in place and the contractor will start the fieldwork within the next 90 days. The Army will keep NMED updated on the progress of the project.
