Enclosed for Mr. Larry Fisher - Tooele Army Depot (TEAD) and as requested by Mr. Tim Alexander, U. S. Army Environmental Center (AEC) Project Manager, please find following submittals regarding the Response to Comments to the Final Resource Conservation and Recovery Act (RCRA) Interim Status Closure Plan for the Open Burning/Open Detonation (OB/OD) Areas at the Fort Wingate Depot Activity (FWDA), Gallup, New Mexico, dated 21 May 1996.

1. one (1) "clean copy" of the Interim Status Closure Plan (i.e., with the deleted or "strike-out" text removed from the document, the underline (or "redline") removed from the text, and the bolded Comment reference removed from the text);
2. three (3) copies of the OB/OD Areas Closure Field Program - Work Plans which includes the Field Sampling Plan (FSP) and Contaminated Materials Handling Plan (CMHP), containing the "strike-out" and underline (or "redline") text and the bolded Comment reference;
3. one (1) "clean copy" of the FSP (i.e., with the deleted or "strike-out" text removed from the document, the underline (or "redline") removed from the text, and the bolded Comment reference removed from the text);

4. one (1) copy of the revised Tables to the OB/OD Areas Closure Field Program - Quality Assurance Project Plan (QAPP), and
5. an electronic copy of items 1, 2, and 3 detailed above on a 3.5 " diskette in WordPerfect 5.2 format.

For your clarification we have also enclosed a listing of the pages, tables, figures, and appendices that were impacted by the Response to Draft U. S. Environmental Protection Agency (USEPA) Comments on the FWDA Interim Status Closure Plan Documents, dated May 21, 1996.


As we had previously discussed in our telephone conversation of 17 January 1997, it was not required to submit the OB/OD Area Closure Field Program - Health and Safety Plan (HSP), or resubmit a copy of the Closure Plan containing the "strike-out" and "redlined" text as you had confirmed that the 19 December 1996 submittal of the "strike-out" and "redlined" Closure Plan was acceptable. It was also agreed during the 17 January telephone conversation that submittal of the text of the QAPP was not required because the Responses to Comments did not require revision/edit to the text of the QAPP (only to Tables 7-1 through 7-4; which have been enclosed).

Consistent with the 19 December 1996 submittal, where changes have been made to the text of the 21 May 1996 document, the original text has been "stricken through" and revised/additional/new text has been "redlined" (i.e., "underlined"). Further, each portion of stricken and underlined text has been annotated either with reference to an editorial revision/deletion (performed to ensure consistency/clarity within the document and/or with revised/additional/new text) or to the Draft USEPA Comment(s) that necessitated the revision. Please note that revised/new figures and tables have been included and that unchanged figures, tables and appendices (from the 21 May 1996 document) have not been included.

Please also note that based on a 22 January 1997 telephone conversation with Mr. Chuck Hendrickson, USEPA, Region VI, the concerns stated in a 27 November 1996 correspondence to you from Mr. David Neleigh, Section Chief, New Mexico - Federal Facilities, Multimedia Planning and Permitting Division, USEPA Region VI regarding Comment No. 9 have been addressed and require no changes to the Closure Plan. Further, as also discussed with Mr. Hendrickson, the additional concerns regarding Comment Nos. 2, 21, and 30 require no changes in the Closure Plan submittal.
