The purpose of this letter is to notify you that the Army has reviewed the draft Kickout Area Delineation Report prepared by our contractor. The delineation is being conducted under the work plan approved by NMED on June 5, 2008. Based on our review, the Army has determined the kickout area has not been adequately defined and has requested the contractor re-mobilize to complete the work in accordance with the contract and permit. The contractor will mobilize on or about March 30 2009 and continue work through the end of April 2009 pending favorable weather.

The Army will review the revised report afterwards and then the contractor should send the report to the Tribes on or about July 17, 2009. The Tribes have 90 days for review of the report. If you have questions or require further information, please call me at (330) 358-7312.
