Dear Messrs. Patterson and Smith:

The New Mexico Environment Department (NMED) received the Department of the Army's (the Permittee) letter regarding the *Final RCRA Facility Investigation Report Parcel 10B-Arsenic*, dated September 18, 2013 in response to comments made by NMED dated May 7, 2013 for the Final RCRA Facility Investigation Report (RFI) Parcel 10B, dated, March 19, 2012. The intent of the letter dated September 18, 2013 was to request no further action (NFA) for Parcel 10B at area of concern (AOC) 44 and Solid Waste Management Unit (SWMU) 26 based on the 2009 and 2012 arsenic and antimony soil background study.

The Permittee proposed NFA at AOC 44 and SWMU 26 based on the 2009/2012 95th upper tolerance limit (UTL) of 4.6 milligrams per kilogram (mg/kg) for soil unit 225. However, in a letter dated December 18, 2013 the NMED has determined the arsenic background concentration

of 5.2 mg/kg is acceptable for Fort Wingate Depot Activity (FWDA) provided there are no possible sources of arsenic related to historic Army operations at that site. The exceedances found in Parcel 10B range from 4.2 mg/kg – 4.3 mg/kg. Therefore, NMED has determined that additional corrective action is not required at Parcel 10B for AOC 44 and SWMU 26. The Permittee may submit a petition for corrective action complete for these sites.
