The Army is respectfully withdrawing the document titled *Final Investigation Report Igloo Block A Parcel 9, Fort Wingate Depot Activity, McKinley County, New Mexico,* dated July 2018, from further review due to administrative purposes since Igloo Block A is within the scope of the Parcel 9 RFI Work Plan and the future RFI Report. NMED rejected the subject document in their letter dated October 2, 2018. Further continuance of this report in addition to the Parcel 9 RFI documents and will be confusing for all parties. Parcel 9 includes Igloo Block A (AOC 18) and AOC 85, therefore the Army prefers to include all sites in Parcel 9 in the RFI Work Plans and Report. The Army will include the results of this investigation in the Parcel 9 RFI Report as indicated in our Notification of Anticipated Non-Compliance letter dated December 20, 2019.
