
The New Mexico Environment Department (NMED) received the Department of the Army's (The Permittee) letter, dated November 3, 2010 requesting a time extension for submittal of the *RCRA Facility Investigation (RFI) Report for Parcel 21* (Report) from December 1, 2010 to February 16, 2011. The stated reason for the extension of time is due to the contract laboratory's failure to provide usable data for a substantial number of soil samples. As a result the Permittee re-sampled all the sites where the data quality problems occurred and to obtain valid data using a different laboratory. NMED hereby approves the extension for the submittal of the Report. The Permittee must submit the Report no later than February 16, 2011.
