
The New Mexico Environment Department (NMED) has reviewed the *Final Investigation and Remediation Completion Report, Parcel 18, Solid Waste Management Unit 13 (Eastern Landfill)* (Report), dated December 12, 2014 for Fort Wingate Depot Activity. The Report summarizes the results of the investigation and remediation conducted at SWMU 13. This included waste delineation, source removal and confirmatory sampling at SWMU 13, the Eastern Landfill. NMED has reviewed the Report and hereby issues this approval.

Based on this Report NMED has determined that no additional corrective action is required at Parcel 18 for SWMU 13. The Permittee may submit a petition to change the status of the site from corrective action required to corrective action complete without controls.
