RE: CLARIFICATION ON SUBMITTAL DATES FOR MULTIPLE DOCUMENTS FORT WINGATE DEPOT ACTIVITY MCKINLEY COUNTY, NEW MEXICO EPA # NM6213820974 HWB-FWDA-MISC

Dear Messrs. Patterson and Smith:

NMED recently performed a tracking audit for the Fort Wingate Depot Activity (Permittee) administrative record. Upon review, four approval letters provided by NMED to the Permittee were found to not include a specific submittal date for the next document in the progression. While it has been conveyed to the Permittee that approval of a work plan indicates approval of the schedule presented in the work plan, confusion has been apparent. Therefore, NMED is providing this letter as clarification. The table on the following page provides the NMED tracking number, the document title, the rationale for the submittal date, and the submittal date. Two of the four dates have already been surpassed; therefore, the Permittee must submit extension requests for those two reports as soon as possible in order to remain in compliance with the facility's Permit.

In addition, NMED's December 30, 2017 Approval with Modifications letter for the Northern Area Background Well Installation Letter Work Plan failed to include the requirement for submittal of a Well Installation Report. The Well Installation Report must include details of the soil boring and well installation for the background wells proposed in the Northern Area Background Well Installation Letter Work Plan, including descriptions of work performed in the field, boring logs, well construction diagrams, well development methods, water quality data, and analytical data for initial groundwater sampling.
