The New Mexico Environment Department (NMED) is in receipt of the Fort Wingate Depot Activity (Permittee) letter requesting an extension for the revised *Final Permittee-Initiated Interim Measures Work Plan* (Plan), dated May 22, 2018 and received May 25, 2018. This is the fifth extension request for this document (previous extensions were granted on October 15, 2015, January 12, 2016, November 1, 2016, and May 31, 2017).
