The New Mexico Environment Department (NMED) has received Fort Wingate Depot Activity's (the Permittee) letter requesting an extension of time for the submittal of the *Parcel 20 RCRA Facility Investigation Work Plan*, dated April 29, 2015.

As required by Table VII.2 of the Permit the submittal date for the Work Plan is May 1, 2015. The Permittee requests an extension to submit the Work Plan by June 1, 2015.
