Tammy,

Per our discussion, I am requesting a change from 100 to 50 MI sub-samples at the Bldg 528 area (SWMU27) and the QA Test Area (SWMU70) in the Parcel 22 WP. Most of the units in SWMU 27 are around 1/4 acre - 10,000SF and all the DUs in SWMU70 are about 1/4acre. The larger decision units (DU's) at SWMU27 will have 60 sub-samples per the attached figure. We will bias the sub-samples toward any low areas found in the DU's. One of our staff attended a detailed MI sampling class and found that 50 sub-samples for areas this size are adequately representative and additional sub-samples do not add much to representativeness of areas this size. Thanks
