As shown in the attached figure, the original location of the well was just inside the inner fence boundary. The proposal is to place the well immediately outside the inner fence, approximately 50-80 feet away from the original well's location.

The purpose of this change is to simplify access, improve safety, and avoid impacting the fence. The new location is adjacent to the arroyo that the previous well was targeting, and the elevation is consistent with the previous location.
